### **How to Join Guildford and Kalamunda Districts Swimming Club**

Once you have completed two try out sessions with our club and wish to join please follow the step by step process to join the club:

- Go to [www.gkdsc.com.au](http://www.gkdsc.com.au) and click on the “Membership” tab on the Home page.
- Click on the “New Members” link if you are a brand new member to the club.
- This will direct you to the Swimming WA website.
- Click through the process to enrol swimmer (note a parent will also need to join – this is free)
- At the end of the process you will make payment either via BPAY or via Paypal.
- The cost to join is \$110.00 (SWA Portion) and \$80.00 (club portion) plus a small percentage admin fee. (SWA Portion is discounted from February)

**It is VERY Important that your swimmer is registered with Swimming WA as soon as possible to cover them for Insurance and membership to the club. If they are not registered then they cannot continue to train.**

#### **Training FEES:**

All squad fees are to be paid to the club by the 10<sup>th</sup> of EACH month that the swimmer is training. The club bank account is **633000 160 931 333 Bendigo Forrestfield**. Once payment is made via EFT please email the club treasurer – [treasurer@gkdsc.com.au](mailto:treasurer@gkdsc.com.au) to advise what payment was for. **Starfish** : \$70.00 per month

**Age Development** : \$120 per month

**Seals** : \$80.00 per month

**Senior**: \$120.00 per month

**Dolphins** : \$90.00 per month

**Senior Performance**: \$140.00 per month

**Intermediate (Sharks)** : \$100.00 per month

\*\*\*Note: Swimmers who are students at Guildford Grammar and Darling Range receive a 50% discount on training fees. Parents MUST advise club treasurer of this to ensure correct fees are charged.

### **Transferring to GKDSC from another club**

If your swimmer has been a member of another club then a transfer form (available on our website) needs to be completed. Once you have had your old club sign the form then you will need to have our President, Registrar or Secretary sign the form. You will then need to send the form to Swimming WA, along with the \$35.00 transfer fee, for approval.
